January 31, 2022 (E-127)	Last day to file semi-annual campaign statements (from last statement to 12/31/21). <i>Cal. Gov. Code 84200, 84218</i>
January 31, 2022 (E-127)	First day candidates for judicial offices may file the Declaration of Intention. <i>Cal. Elec. Code §§ 8023</i>
February 9, 2022 (E-118)	Last day for judicial candidates to file the Declaration of Intention. This period is extended if the incumbent does not file. <i>Cal. Elec. Code §§ 8023</i>
February 9, 2022 (E-118)	Signature in lieu collection period closes for all candidates. <i>Cal. Elec. Code §§ 8020(b), 8061, 8106 (b)(3)</i>
February 14, 2022 (E-113)	Close of extended filing period for the Declaration of Intention. <i>Cal. Elec. Code §§ 8023(b)</i>

March 16, 2022 (E-83)	Close of extended candidate filing period. <i>Cal. Elec. Code §§ 8003(b), 8022</i>
March 17, 2022 (E-82)	Random alphabet draw to be held at 11 AM to determine the ballot order of candidates' names. <i>Cal. Elec. Code §§ 13112 (b)(1)(A)</i>
April 11, 2022 (E-57)	Write-in candidate filing period begins. <i>Cal. Elec. Code §§ 8601</i>
April 28, 2022 (E-40)	County Voter Information Guide may begin to be mailed. <i>Cal. Elec. Code §§ 9082, 9094(a), 13300</i>
April 28, 2022 (E-40)	Last day to file 1 <sup>st</sup> pre-election campaign statements (from 1/1/22 to 4/23/22). <i>Cal. Gov. Code 84200, 84218</i>
May 9, 2022 (E-29)	Ballots will be mailed to all registered voters by this date. First day to process ballot requests and returns. <i>Cal. Elec. Code §§ 3001(b), 15101</i>
May 24, 2022 (E-14)	First day for conditional registration for this election. <i>Cal. Elec. Code §§ 331, 3500, 3501, 3502</i>
May 24, 2022 (E-14)	Write-in candidate filing period ends. <i>Cal. Elec. Code §§ 8601, 8604</i>
May 26, 2022 (E-12)	Last day to file 2 <sup>nd</sup> pre-election campaign statements (from 4/24/22 to 5/26/22). <i>Cal. Gov. Code 84200, 84218</i>
May 31, 2022 (E-7)	Last day to request a ballot by mail for this election. <i>Cal. Elec. Code §§ 3001(a)</i>
