Deadlines: File within 24 hours except the deadline for a 497 due February 25 or February 26 is extended to February 27 The recipient of a late non-monetary contribution must file a late contribution report within 48 hours from the time the contribution is received. File personal delivery, guaranteed overnight service, or fax.
Jul 31, 2012 <i>Semi-Annual</i>	2/19/12 – 6/30/12	460	<ul style="list-style-type: none"> All committees must file this report unless the committee filed a termination Form 460 and Form 410 before June 30, 2012.

Additional Election Reports

Depending on committee activity, one or all of the following reports may also be required:

- [465](#) - **Supplemental Independent Expenditure Report:** Committees that make independent expenditures of \$1,000 or more file this report.
- [511](#) - **Paid Spokesperson Report:** File within 10 days of making an expenditure totaling \$5,000 or more to an individual to appear in an advertisement to support or oppose a ballot measure.

- **Period Covered:** The period covered by any statement begins on the day after the closing date of the last statement filed, or January 1, if no previous statement has been filed.
- **Primarily Formed Ballot Measure Committees:** Prior to the semi-annual period in which the measure(s) supported or opposed is being voted upon, committees must file quarterly campaign statements in addition to semi-annual statements. Following the election, quarterly statements may also be required.
- **Method of Delivery:** All paper filings are to be filed by personal delivery or first class mail unless otherwise noted.
- **Filing Deadlines:** Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to Form 497 due March 3 or March 4, 2012, or any Form 496 report. Such reports must be filed within 24 hours regardless of the day of the week. Late statements are subject to a \$10 per day late fine.
- Local jurisdictions may impose contribution limits and additional filing requirements.
- All statements are public documents.
