NOTICE IS FURTHER GIVEN that official Nomination Petitions and Declarations of Candidacy for eligible candidates desiring to file for the above elective offices (except city council races in the cities of Colfax, Lincoln, Loomis, Rocklin and Roseville) may be obtained from the Placer County Office of Elections, 2956 Richardson Drive, Auburn, CA 95603, Monday through Friday from 8:00 AM to 5:00 PM, excluding holidays. For the Tahoe area, Nomination Petitions and Declarations of Candidacy may be picked up at the Tahoe City Library located at 740 North Lake Blvd., Tahoe City, Tuesday through Friday from 12:00 Noon to 4:00 PM, excluding holidays. Completed Declarations of Candidacy shall be returned to the Placer County Office of Elections or the Tahoe City Library for filing. Candidates for Colfax, Lincoln, Loomis, Rocklin and Roseville city offices must obtain their nomination paperwork from their respective City/Town Clerk. Contact the appropriate City Clerk's office for more information.

NOTICE IS FURTHER GIVEN that filing is open Monday, July 12, 2010 and will close Friday, August 6, 2010, after which time no declarations of candidacy may be accepted for filing. If an incumbent does not file his or her declaration of candidacy on or before August 6, 2010, the period for all non-incumbents to obtain and return declarations of candidacy

will be extended to August 11, 2010. Office hours will be the same as above.

NOTICE IS FURTHER GIVEN that consolidated with the Gubernatorial General Election the following measure shall be put to a vote of the qualified voters in the Town of Loomis:

Measure A – Town of Loomis

Shall the proposed ordinance entitled “An Initiative of the Loomis Town Citizens Enacting Term Limits” which provides:” (1) five council members serve 4-year terms; (2) terms shall be staggered; (3) no member can serve more than two consecutive 4-year terms; (4) a member who has served two terms prior to August 1, 2010 must sit out eight years; and (5) current members can complete their terms, be adopted?

NOTICE IS FURTHER GIVEN that consolidated with the Gubernatorial General Election the following measures shall be put to a vote of the qualified voters in the City of Roseville:

Measure B – City of Roseville

Shall the City Charter be amended: (1) Out-of-date provisions: sections 1.055, 2.06, 2.07, 2.10, 2.12, 2.13, 3.02, 3.03, 4.02, 4.05, 5.03; (2) Up-dated provisions: sections: 2.14, 3.09, 8.02, 8.03, 8.04, 8.05, 8.07, 9.01; (3) Typographical corrections: sections 4.06, 6.01; (4) Minor procedural changes: sections 1.05, 2.04, 2.09; (5) Capitalizing the word City, replacing the word member with councilmember, and adding the word City to all named officials?

Measure C – City of Roseville

Shall the City Charter be amended as follows: (1) Section 2.02, providing that a partial City Council term served due to appointment to a vacant council seat does not count as a term for the purposes of this section; and (2) Section 2.05, changing title of mayor pro tempore to vice mayor?

Measure D – City of Roseville

Shall the City Charter be amended as follows: (1) Section 2.03, modifying the time frame for assumption of office by, and seating of, elected councilmembers, to conform to California Elections Code §15372?

Measure E – City of Roseville

Shall the City Charter be amended with respect to minor fiscal matters as follows: (1) Section 7.09 and 7.10, updating Charter to conform to changes in state tax and assessment law beginning with the passage of Proposition 13 in 1978; (2) Section 7.095 deleting and reserving section; (3) Minor procedural and typographical amendments: sections 7.05, 7.06, 7.15, 7.19 and 7.20?

Measure F – City of Roseville

Shall the City Charter be amended with regard to certain fiscal matters as follows: (1) Section 7.21, allowing adoption of an ordinance establishing bidding preference for

businesses located within the City of Roseville?

Measure G – City of Roseville

Shall the City Charter be amended with regard to certain fiscal matters as follows: (1) Section 7.21, increasing dollar amount of items requiring a sealed bid from \$10,000 to \$19,500?

Measure H – City of Roseville

Shall the City Charter be amended as follows: (1) Section 2.02, providing that term limits be modified from two (2) consecutive four (4) year terms to three (3) terms of four (4) years each, such that a person would be ineligible to hold office after serving on the Council for three (3) four (4) year terms?

NOTICE IS FURTHER GIVEN that consolidated with the Gubernatorial General Election the following measure shall be put to a vote of the qualified voters in the Western Placer Unified School District:

Measure J – Western Placer Unified School District

To help protect local schools from state budget cuts, improve the quality of education at all our local schools, modernize classroom technology and job training programs, construct new science and computer labs, improve school safety, build new classrooms and become eligible for millions in additional state school construction grants, shall the Western Placer Unified School District issue \$163 million in bonds at lawful interest rates with citizens' oversight and no money for administrator salaries?

NOTICE IS FURTHER GIVEN that consolidated with the Gubernatorial General Election the following measure shall be put to a vote of the qualified voters in the City of Lincoln:

Measure K – City of Lincoln

**Temporary City of Lincoln Essential City Services Protection Measure.** To help maintain and protect Lincoln's financial viability and essential services including 9-1-1 emergency/medical response times, helping prevent cuts to police officers, firefighters, library and recreation services, shall the City of Lincoln establish a temporary 3.75% utility users tax ordinance that expires in 4 years, with annual independent audits, public expenditure reports, citizens oversight, low-income senior exemptions, with all revenue dedicated solely for Lincoln and not the State?

NOTICE IS FURTHER GIVEN that consolidated with the Presidential General Election the following measure shall be put to a vote of the qualified voters in the Auburn Union School District:

Measure L – Auburn Union School District

To preserve quality education, protect schools from state budget cuts and provide stable funding that cannot be taken by the state to preserve reading, math and science instruction; maintain hands-on science programs, classes and labs; maintain reading and

language programs for all students; and attract and retain qualified teachers, shall Auburn Union School District levy \$59 per parcel annually for 5 years with an exemption for seniors, independent oversight and no money for administrators' salaries?

NOTICE IS FURTHER GIVEN that direct arguments for or against said measure(s) shall be submitted to the Placer County Office of Elections (except arguments for municipal measures). Said arguments shall not exceed 300 words in length and may be received or withdrawn, but not changed, prior to and including August 6, 2010 at 5:00 PM. The Placer County Registrar of Voters shall cause (if submitted) one argument for and/or one argument against said measure(s) to be printed and shall cause to be enclosed a copy thereof in each sample ballot. If multiple arguments are submitted either for or against a measure, the Placer County Registrar of Voters shall choose and print one argument in accordance with applicable law or procedure. Arguments for measures A, B, C, D, E, F, G, H, and K will be filed with the respective City Clerk. Contact the appropriate City Clerk's office for more information.

NOTICE IS FURTHER GIVEN that, for individuals interested in submitting arguments for or against said measure(s), the physical address for the Placer County Office of Elections is 2956 Richardson Drive, Auburn. The mailing address for the Placer County Office of Elections is PO Box 5278, Auburn, CA 95604.

NOTICE IS FURTHER GIVEN that when the Placer County Registrar of Voters has selected the direct arguments for and against said measure(s), the Placer County Registrar of Voters shall send copies of the argument in favor of said measure(s) to the authors of the argument against and copies of the argument against to the authors of the argument in favor. The authors may prepare and submit rebuttal arguments not to exceed 250 words. The rebuttal arguments must be filed with the Placer County Registrar of Voters not later than 10 days after the final date for filing direct arguments. The final date for rebuttal arguments is August 16, 2010 at 5:00 PM.

NOTICE IS FURTHER GIVEN that California Elections Code Section 9600 governs the form of said arguments and/or rebuttals. Arguments and/or rebuttals submitted to the Placer County Office of Elections must follow this form. Authors of said arguments/rebuttals may call the Office of Elections at 530-886-5650 for more information and a copy of this Elections Code Section.

NOTICE IS FURTHER GIVEN that the last day to register to vote for the Gubernatorial General Election is October 18, 2010.

NOTICE IS FURTHER GIVEN that vote-by-mail ballots will begin to mail on October 4, 2010. The last day for the Office of Elections to mail a requested vote-by-mail ballot is October 26, 2010.

NOTICE IS FURTHER GIVEN that at the Gubernatorial General Election the polls will be open from the hour of 7:00 AM to the hour of 8:00 PM on the day thereof.

NOTICE IS FURTHER GIVEN that after the polls are closed on the date of said election, the ballots will be transported to the central counting location at the Placer County Office of Elections, 2956 Richardson Drive, Auburn, CA 95603.

NOTICE IS FURTHER GIVEN that the opening and processing of the vote-by-mail ballots for said election will take place at the Placer County Office of Elections starting October 22, 2010 and continue through Election Night, November 2, 2010.

NOTICE IS FURTHER GIVEN that the canvass will commence on or before 8:00 AM on November 4, 2010 at the Placer County Office of Elections.

NOTICE IS FURTHER GIVEN that the Office of Elections will be open for business the two weekends prior to the Gubernatorial General Election (October 23<sup>rd</sup> and 24<sup>th</sup> and October 30<sup>th</sup> and 31<sup>st</sup>) from 9:00 AM to 4:00 PM.

NOTICE IS FURTHER GIVEN, in accordance with provisions of the election laws of the State of California, that on November 3, 2010 at 10:00 AM, the Placer County Office of Elections will randomly select precincts for a manual tally of one percent (1%) of the precincts casting ballots at the November 2, 2010 Gubernatorial General Election.

NOTICE IS FURTHER GIVEN that this random selection of precincts is open to the public.

NOTICE IS FURTHER GIVEN that on November 15, 2010 at 9:00 AM, the Placer County Office of Elections will begin a manual tally of one percent (1%) of the precincts casting ballots at the November 2, 2010 Gubernatorial General Election.

NOTICE IS FURTHER GIVEN that this manual tally is open to the public and shall continue daily (Saturdays, Sundays and holidays excluded unless otherwise decided by the County Registrar of Voters) until completed.
