NOTICE IS FURTHER GIVEN that official Nomination Petitions and Declarations of Candidacy for eligible candidates desiring to file for the above elective offices (except city council races in the cities of Colfax, Lincoln, Loomis, Rocklin, and Roseville) may be obtained from the Placer County Office of Elections, 2956 Richardson Drive, Auburn, CA 95603 beginning July 14, 2014, Monday through Friday from 8:00 AM to 5:00 PM, excluding holidays. For the Tahoe area, Nomination Petitions and Declarations of Candidacy may be picked up at the Customs House Building located at 775 North Lake Blvd., Tahoe City, Monday through Friday from 11:00 AM to 3:30 PM beginning July 16, 2014, excluding holidays. Completed Declarations of Candidacy shall be returned to the Placer County Office of Elections or the Customs House Building for filing. Candidates for Colfax, Lincoln, Loomis, Rocklin and Roseville city offices must obtain their nomination paperwork from their respective City/Town Clerk. Contact the appropriate City Clerk's office for more information.

NOTICE IS FURTHER GIVEN that filing is open Monday, July 14, 2014 and will close Friday, August 8, 2014, after which time no declarations of candidacy may be accepted for filing. If an incumbent does not file his or her declaration of candidacy on or before August 8, 2014, the period for all non-incumbents to obtain and return declarations of candidacy will be extended to August 13, 2014. Office hours will be the same as above.

NOTICE IS FURTHER GIVEN that consolidated with the Statewide General Election the following measure shall be put to a vote of the qualified voters in the Western Placer Unified School District:

Measure A – Western Placer Unified School District

To protect quality education, shall Western Placer Unified School District construct a new high school, and improve Lincoln High School by updating/replacing aging classrooms and support facilities, and instructional technology needed for improved teaching, replacing portable classrooms, repairing/replacing roofs, worn-out floors, electrical systems, seismic upgrades and improving energy efficiency to save money and support instruction by issuing \$60,000,000 in bonds at legal rates, with independent oversight, no money for administrators and all money staying local?

NOTICE IS FURTHER GIVEN that consolidated with the Statewide General Election the following measures shall be put to a vote of the qualified voters in the Tahoe Truckee Unified School District:

Measure E – Tahoe Truckee Unified School District

To improve Tahoe area schools with local funding that the State cannot take away, repair/replace roofs, plumbing and electrical systems, provide classrooms, science labs and technology meeting modern academic safety standards and providing a well-rounded education, construct, equip, repair, acquire school facilities/equipment to prepare students for college/high-demand jobs, shall School Facilities Improvement District No. 2 of the Tahoe-Truckee Unified School District issue \$62,000,000 in bonds at legal rates with independent audits, citizen oversight, and no funds for administrators' salaries?

Measure U – Tahoe Truckee Unified School District

To improve Truckee area schools with funding that the State cannot take away, repair/replace roofs, plumbing and electrical systems, help local schools qualify for State matching funds, and construct, equip, repair/acquire classrooms, science labs, career technical education facilities to provide a well-rounded education and prepare students for college/high-demand jobs, shall School Facilities Improvement District No. 1 of the Tahoe-Truckee Unified School District issue \$114,000,000 in bonds at legal rates with independent audits, citizen oversight, and no funds for administrators' salaries?

NOTICE IS FURTHER GIVEN that direct arguments for or against said measure(s) shall be submitted to the Placer County Office of Elections (except arguments for municipal measures). Said arguments shall not exceed 300 words in length and may be received or withdrawn, but not changed, prior to and including August 8, 2014 at 5:00 PM. The Placer County Registrar of Voters shall cause (if submitted) one argument for and/or one argument against said measure(s) to be printed and shall cause to be enclosed a copy thereof in each sample ballot. If multiple arguments are submitted either for or against a measure, the Placer County Registrar of Voters shall choose and print one argument in accordance with applicable law or procedure.

NOTICE IS FURTHER GIVEN that, for individuals interested in submitting arguments for or against said measure(s), the physical address for the Placer County Office of Elections is 2956 Richardson Drive, Auburn. The mailing address for the Placer County Office of Elections is PO Box 5278, Auburn, CA 95604.

NOTICE IS FURTHER GIVEN that when the Placer County Registrar of Voters has selected the direct arguments for and against said measure(s), the Placer County Registrar of Voters shall send copies of the argument in favor of said measure(s) to the authors of the argument against and copies of the argument against to the authors of the argument in favor. The authors may prepare and submit rebuttal arguments not to exceed 250 words. The rebuttal arguments must be filed with the Placer County Registrar of Voters not later than 10 days after the final date for filing direct arguments. The final date for rebuttal arguments is August 18, 2014 at 5:00 PM.

NOTICE IS FURTHER GIVEN that California Elections Code Section 9600 governs the form of said arguments and/or rebuttals. Arguments and/or rebuttals submitted to the Placer County Office of Elections must follow this form. NOTICE IS FURTHER GIVEN that the last day to register to vote for the Statewide General Election is October 20, 2014.

NOTICE IS FURTHER GIVEN that vote-by-mail ballots will begin to mail on October 6, 2014. The last day for the Office of Elections to mail a requested vote-by-mail ballot is October 28, 2014.

NOTICE IS FURTHER GIVEN that at the Statewide General Election the polls will be open from the hour of 7:00 AM to the hour of 8:00 PM on the day thereof.

NOTICE IS FURTHER GIVEN that after the polls are closed on the date of said election, the ballots will be transported to the central counting location at the Placer County Office of Elections, 2956 Richardson Drive, Auburn, CA 95603.

NOTICE IS FURTHER GIVEN that the opening and processing of the vote-by-mail ballots for said election will take place at the Placer County Office of Elections starting October 20, 2014 and continue through Election Night, November 4, 2014.

NOTICE IS FURTHER GIVEN that on November 17, 2014 at 9:00 AM, the Placer County Office of Elections will begin a manual tally of one percent (1%) of the precincts casting ballots at the November 4, 2014 Statewide General Election.

NOTICE IS FURTHER GIVEN that this manual tally is open to the public and shall continue daily (Saturdays, Sundays and holidays excluded unless otherwise decided by the County Registrar of Voters) until completed.
