Top Two Candidates Open Primary Act and Voter-Nominated Offices: Under the Top Two Candidates Open Primary Act of June 2010, all candidates running in a primary election, **regardless of their party preference**, will appear on a single primary election ballot and voters can vote for any candidate (voter-nominated office). The top two overall vote-getters – not the top vote-getter from each qualified political party – will move on to the general election. **Please Note: The Top-Two Candidates Open Primary Act does not apply to candidates running for partisan offices such as United States President or county central committee.**
