All voters registered within the Northstar Community Services District should start checking their mailboxes for the November 2, 2021, Community Service District Special Election Voter Information Guide and ballot packet. Voter Information Guides and ballot have been mailed out to all registered voters in the Northstar Community Services District. The Voter Information Guide will provide voters with important information regarding the measure to be voted on this election. In addition, a list of secure drop box locations and the Election Day polling place are listed within the guide.

All active registered Northstar Community Services District voters will be issued a ballot by mail for the November 2, 2021, Community Service District Special Election as required by Senate Bill 29 which requires county election officials to issue ballots by mail to all active registered voters through January 1, 2022. Ballots were mailed out to voters October 4. Voters may request a replacement ballot to be mailed to them by calling our Elections Office at 530-886-5650 or toll-free in California 1-800-824-8683. You may pick up a ballot in our Elections Office through Election Day, November 2. The Elections Office is located at 2956 Richardson Drive in Auburn. Office hours are Monday through Friday, 8:00 AM to 5:00 PM. Election Day hours are 7:00 AM to 8:00 PM.

Placer County is offering a remote accessible vote by mail (RAVBM) option to all registered voters for this election. RAVBM is an accessible option for voters to receive their ballots digitally at home and mark them independently and privately before mailing them back to us. Please visit www.placercountyelections.gov or call our Elections Office at (530) 886-5650 to request further information.

The Elections Office will be staffing one polling place at Northstar Community Services District located at 900 Northstar Drive in Truckee, which will offer in person voting, voter

registration, accessible ballot marking devices, and language assistance. If you choose not to return the ballot that was mailed to you and want to vote at your polling place instead, we strongly encourage you to surrender your vote by mail ballot to avoid voting provisionally.

If you do not receive your Voter Information Guide or ballot by October 26 or if you misplace your Voter Information Guide or ballot, please contact the Elections Office at 530-886-5650 or toll free in California 1-800-824-8683 for a duplicate voter information guide and/or replacement ballot.

If you have interacted recently with the DMV, your voter registration information may have been changed. It is important to confirm your voter status, political party preference, address, and all other pertinent information to make sure you are still registered correctly. Check your status at voterstatus.sos.ca.gov.
