NOTICE OF PROPOSED VOTER SERVICE CENTERS AND VOTE BY MAIL BALLOT DROP BOX LOCATIONS NOVEMBER 3, 2020 GENERAL ELECTION

August 27, 2020

In accordance with this year's California Assembly Bill 860, California Senate Bill 423, and the Governor's Executive Orders, California has significantly changed the election process for the November General Election. **All active registered voters will receive a vote by mail ballot** for the November 3, 2020 General Election. We will place 20 ballot drop boxes around the county for the return of vote by mail ballot should voters not want to return their ballot by mail. Voters may receive a replacement ballots by contacting the Elections Office or by visiting one of our 29-day voting locations in Auburn or Rocklin. Additionally, we will offer 28 in-person voting locations throughout the county which will offer voting assistance, in person voting and replacement vote by mail ballots. The 28 locations will be open Saturday, October 31, 2020 through Tuesday, November 3, 2020. However, voters who wait until Election Day to vote should expect lines – and possibly even long lines and wait times – in order to vote. Fewer voting locations combined with new regulations from the state as to how many people can enter a center at one time will cause lines to back up. We are going to do everything in our power to mitigate lines, but would encourage all voters to use the vote by mail option or show up to the voter service center on the Saturday, Sunday or Monday before Election Day to avoid the lines.

Prior to finalizing locations, Placer County is accepting public comments on the proposed voter service center, 29-day voting, and ballot drop off locations for the November 3, 2020 General Election. A list of the proposed locations is below for review and public comment for ten days, ending on September 6, 2020.

Public comment can be made by submitting your comments at election@placer.ca.gov, or by calling (530) 886-5650.

The County Clerk-Recorder-Registrar of Voters will consider any comments received from the public and adjust locations to the extent deemed appropriate before finalizing the locations.
