The Presidential General Election is November 4, 2008. It may not seem like it is approaching quickly, but candidate filing is just around the corner. Every general election there are approximately 180 offices for which Placer County residents may run, the majority of them for local districts. If you are interested in serving your local community, please consider filing for office.

Candidate filing opens July 14, 2008 and closes August 8, 2008. If the Incumbent fails to file by August 8, the filing period for that office will be extended to August 13, 2008 for individuals other than the incumbent.

Placer County residents in the Tahoe area will also be able to file at the Tahoe City Library located at 740 North Lake Blvd, Tahoe City. Candidates can file for office there Tuesday through Friday from 12:00 PM to 5:00 PM. Because the library is closed on Mondays, candidate filing in Tahoe will begin on July 15, 2008 instead of July 14.
