NOTICE IS HEREBY GIVEN by Ryan Ronco, Placer County Clerk-Recorder-Registrar of Voters, in accordance with the provisions of the Election Laws of the State of California, on August 27, 2019 there will be a Special Primary Election to be held for California State Assembly, 1st District.

NOTICE IS FURTHER GIVEN that the signature in lieu of filing fee collection period began June 19, 2019 and ended on June 25, 2019.

NOTICE IS FURTHER GIVEN that official nomination petitions and declarations of candidacy were obtained from the Placer County Elections Office, 2956 Richardson Drive, Auburn, CA 95603.

NOTICE IS FURTHER GIVEN that candidate filing opened June 19, 2019 and closed July 3, 2019.

NOTICE IS FURTHER GIVEN that the write-in period began July 1, 2019 and ends August 13, 2019.

NOTICE IS FURTHER GIVEN that the hours for filing nomination petitions and declarations of candidacy during the filing period will be Monday through Friday, 8:00 AM to 5:00 PM excluding holidays.

NOTICE IS FURTHER GIVEN that the last day to register to vote for the Special Primary Election is August 12, 2019.

NOTICE IS FURTHER GIVEN that vote by mail ballots will begin to mail on July 29, 2019. The last day for the Elections Office to mail a requested vote by mail ballot is August 20, 2019.

NOTICE IS FURTHER GIVEN that at the Special Primary Election the polls will be open from the hour of 7:00 AM to the hour of 8:00 PM on the day thereof.

NOTICE IS FURTHER GIVEN that after the polls are closed on the date of said election, the ballots will be transported to the central counting location at the Placer County Elections Office, 2956 Richardson Drive, Auburn, CA 95603.

NOTICE IS FURTHER GIVEN that the opening and processing of the vote by mail ballots for said election will take place at the Placer County Elections Office starting August 13, 2019 and continue through Election Night, August 27, 2019.

NOTICE IS FURTHER GIVEN that the canvass will commence on or before 8:00 AM on

August 28, 2019 at the Placer County Elections Office.

NOTICE IS FURTHER GIVEN that the Elections Office will be open for business the weekend prior to the Special Primary Election, August 24 and 25, from 9:00 AM to 4:00 PM.

NOTICE IS FURTHER GIVEN, in accordance with provisions of the election laws of the State of California, on August 28th at 10:00 AM, the Placer County Elections Office will randomly select precincts for a manual tally of one percent (1%) of the precincts casting ballots at the August 27, 2019 Special Primary Election.

NOTICE IS FURTHER GIVEN that this random selection of precincts is open to the public.

NOTICE IS FURTHER GIVEN that on August 29, 2019 at 9:00 AM, the Placer County Elections Office will begin a manual tally of one percent (1%) of the precincts casting ballots at the August 20, 2019 Special Primary Election.

NOTICE IS FURTHER GIVEN that this manual tally is open to the public and shall continue daily (Saturdays, Sundays, and holidays excluded, unless otherwise decided by the County Registrar of Voters) until completed.
